1. Invitation

You are invited to participate in a research study examining microplastic pollution associated with ports and shipping activities.

2. What is the purpose of this study?

Microplastics (plastic particles <5 mm) are detrimental to the environment and our health. There is limited information available to the maritime community on how ports and shipping activities contribute to microplastics pollution and how to manage this problem. This study aims to assist maritime industry stakeholders in finding practical and viable solutions for reducing ocean plastic contamination.



The aims of the project are:

- 1. To explore differences in the levels of microplastic contamination in port and non-port sites across two geographical locations.
- 2. To develop policy imperatives and microplastic pollution mitigation strategies for the maritime industry.
- 3. To raise awareness of microplastics pollution caused by ports and shipping activities and to promote best practices among maritime industry stakeholders.

Key outputs from the project include:

- A White Paper on the release of microplastics into the marine environment through ports and shipping activities and options for limiting their release.
- An information-sharing webinar with the maritime community.
- Infographic and educational materials.
- Journal articles.

3. How is the study being funded?

This study is supported by a grant from the Department of Foreign Affairs and Trade, Government of Australia (99,727 AUD).

4. Why have I been invited to participate?

You are eligible to take part in this study because you are a key stakeholder in the maritime industry. Your participation will contribute to improved understanding and awareness of microplastic pollution and its more effective management in the maritime industry.

Your participation is voluntary. You can withdraw your participation from this study at any time without providing an explanation.

5. What will I be asked to do?

You will be invited to participate in an online workshop with other maritime stakeholders and the research team. The workshop will establish priorities and determine a range of policy imperatives and viable mitigation strategies to reduce ocean microplastic contamination due to ports and shipping activities.

Prior to the workshop, you will be asked to fill out a consent form. The workshop will be conducted via Microsoft Teams in 2-hour sessions centred around a particular theme(s). You can choose to participate in one or more sessions. You can choose to participate via video/audio or via the chat function only. The identities of all participants will be visible to each other.

The online workshop sessions will be recorded and automatically transcribed. If requested within 14 days following the workshop, you will be provided access to the transcription to review your contribution.

6. Are there any possible benefits from participation in this study?

There are no direct benefits to individual participants. However, project findings will contribute to improved knowledge base for maritime stakeholders in making



informed decisions for managing microplastics pollution. The project team will email you the White Paper once written.

7. Are there any possible risks from participation in this study?

You will need to participate in the online workshop using a computer, smartphone or similar device. Please feel free to periodically leave/join the meeting to avoid fatigue.

8. What if I change my mind during or after the study?

You can leave the workshop anytime without providing an explanation. You will have 14 days after the workshop to withdraw your contribution. After this time, your data will be de-identified and included in the analysis.

9. What will happen to the data when this study is over?

Raw data will be stored on a University of Tasmania server for five years after which it will be destroyed.

10. How will the results of the study be published?

Findings from the study will be published in a White Paper and journal articles. An infographic will also be produced for potential use by maritime industry stakeholders.
